



ABOUT YOUR DIVIDEND PAYMENT

- The Entrust dividend is paid to the person named on the power bill at midnight Wednesday 3 August 2016. It cannot be transferred to another person.
- CHEQUE: If you cannot bank the cheque, send it back with the letter that came with it and we will pay the money to the power account.
- CREDIT TO POWER ACCOUNT: The dividend was paid as a credit because you requested it or that's how it was paid to you last year. Please allow a few weeks for the dividend payment to show up on your power bill. Next year you can request a cheque or direct credit when we send out the update forms.
- DIRECT CREDIT: The dividend was paid to the account number shown on the letter. If this number is not correct, call 0508 ENTRUST (0508 368 7878).
- If you requested a direct credit but received a cheque it means we could not process your direct credit request this time.

- 'Oku totongi atu 'a e tiviteni Entrust ki he tokotaha 'oku 'asi 'a hono hingoa' 'i he mo'ua 'uhila 'o e 'aho 3 'o 'Akosi 2016.
 - 'Oku 'ikai lava ke liliu 'eni ki ha toe tokotaha kehe ange.
 - SIEKE: Kapau 'oku 'ikai lava ke ke toho 'a e sieke', fakafoki mai 'eni fakataha mo e tohi na'e 'oatu fakataha mo ia' pea te mau totongi 'a e pa'anga' ki he 'akauni 'uhila'.
 - TOTONGI KULĒTITI KI HE 'AKAUNI 'UHILA': Na'e totongi kulētiti atu 'a e tiviteni koe'uhī he na'a' ke kole mai ke fakahoko 'eni, pe ko e founga ia na'e totongi atu ai 'eni 'i he ta'u kuo hili'. Kātaki o faka'atā ha ngahi laui uike si'i ke 'asi atu ai 'a e totongi kulētiti ko 'eni' 'i ho'o mo'ua 'uhila'. Kapau na'a' ke kole mai ke fakahoko ha totongi kulētiti fakahangatonu ki ho'o 'akauni pangikee' ka na'a' ke ma'u atu 'e koe ha sieke, 'oku 'uhinga 'eni na'e 'ikai ke mau lava 'o fakahoko 'a e totongi kulētiti fakahangatonu ko 'eni' 'i he ta'u' ni. 
배당금 지급과 관련된 안내사항

- Entrust 배당금은 2016년 8월 3일 현재의 전기요금 고지서에 기재된 명의자에게 지급됩니다. 수령자를 다른 사람으로 바꿔 지급되게 할 수 없습니다.
 - 수표: 수표를 은행에 입금할 수 없을 경우에는 지금 통지서와 함께 수표를 저희에게 반송해 주시면 그 금액을 전기요금에서 공제해 드리겠습니다.
 - 전기요금에서 공제: 귀하가 요청했거나 아니면 작년에 이런 방식으로 처리되었기 때문에 전기요금에서 공제하는 방식으로 배당금이 지급되었습니다. 지금 배당금이 실제로 전기요금 고지서에 반영되기까지는 몇 주 정도 시간이 걸립니다. 원하시는 분은 내년에 저희가 업데이트 신청서를 보내 드릴 때 수표나 계좌이체 방식으로 바꿔달라고 요청하시면 됩니다.
 - 계좌이체: 지금 통지서에 표시된 계좌번호로 배당금이 지급되었습니다. 이 계좌번호가 잘못된 경우에는 전화 0508 ENTRUST (0508 368 7878)로 저희에게 알려 주십시오. 계좌이체 방식을 요청했는데도 수표가 우송되었습니다면 저희가 금년에 계좌이체 처리를 할 수 없었기 때문입니다. 내년에 저희가 업데이트 신청서를 보내 드릴 때 계좌이체 방식으로 바꿔달라고 다시 요청하시기 바랍니다.

Kenny says a big thank you to the hundreds of people who sent submissions to the Electricity Authority telling them you don't support the changes they are proposing. A big chirpy thank you also goes to the 274,000 people who checked out the hip-hop video about the proposal on our Facebook page.

The proposal means Aucklanders would end up paying an extra \$78 million a year, while electricity generators will benefit financially from the changes. We say spread transmission costs fairly across all users of the grid including the power generators. This would save customers around \$100 each a year. To us, Kenny, and everyone who made submissions, that's a much better option.



You receive an Entrust dividend if you're someone who pays Vector lines charges in the Entrust district of Auckland, Manukau, northern Papakura and eastern Franklin. If this flyer landed in your letterbox, chances are that includes you.

The dividend is paid to you by us at Entrust, a private trust that owns the majority of Vector on behalf of our 320,000 Entrust beneficiaries.

HOW IT WORKS:

1. VECTOR DISTRIBUTES THE POWER

Vector has a portfolio of businesses providing electricity, gas, fibre optics, smart meters, solar and battery, and new energy solutions to more than a million customers. If you live in the Entrust district, Vector makes sure your power gets to your doorstep. It doesn't matter which retailer you choose, they all use Vector's line network.

2. ENTRUST DISTRIBUTES THE PROFITS

Vector is a successful business. As the proud majority shareholder, Entrust receives a dividend every year from Vector's profits. After covering its administration costs, Entrust then makes a payout to everyone who pays Vector line charges in the Entrust district. That means Entrust sends money to people like you.

ENTRUST - AN INDEPENDENT TRUST

Entrust is an independent trust, not council owned. It was set up in 1993 for a duration of 80 years, meaning it will ensure Vector is a locally owned, well-run business providing a stable electricity supply and serves New Zealanders' interests until 2073.

WE'VE CHANGED OUR NAME

You may have known us as the AECT, or simply as the organisation which sends you a cheque in the mail every year. Maybe you thought we were part of Auckland Council or the Government. So to help clarify who we are and what we do, we changed our name. It's not a major change, just a simple combination of energy and trust - Entrust.

BRINGING POWER TO THE PEOPLE

Not only do we distribute dividends to our Entrust beneficiaries, we keep an eye out for Auckland's power interests. We do this in many ways, like supporting the new undergrounding projects in the district, the installation of electric vehicle infrastructure, or campaigning for a fairer transmission pricing model.

Frequently asked questions

CAN I CHANGE THE NAME ON THE CHEQUE?

No. For your security, the dividend cheque is not transferable. It must be deposited in a bank account in the same name as shown on the cheque. If your name is wrong, get it fixed with your retailer for next time. (Customer data is sent to us by all retailers. If they've got it wrong, we will get it wrong too.) If you can't bank the cheque you can return it and have your dividend credited to your power bill instead. See the form attached to your cheque to find out how.

WHO RECEIVES THE DIVIDEND?

Providing you're in the Entrust district, the Entrust dividend is paid to the person named on the power bill at midnight Wednesday 3 August 2016.

WHY HAVEN'T I GOT MY DIRECT CREDIT OR POWER ACCOUNT CREDIT YET?

Payments were made on the 21st of September 2016. If you were expecting a direct credit, check that the bank account shown on the letter is right – call us ASAP if it isn't. If your account number is correct but you haven't received your dividend, please contact your bank as it may be in a bank holding account (UPI). Credit to power accounts will show up on your power bill, but how long this will take depends on your power company's billing cycle.

- Ka utua te utu moni hua ki te tangata kua whakaingoatia i te kaute hiko i te 3 o Here-turi-kōkā 2016. Kāore e taea te whakawhiti ki tētahi tangata kē.
- TE HAKI: Ki te kore koe e āhei ki te pēke i te haki, whakahokia mai me te reta i tae tahī ai me ia, ā, ka utua e mātou te moni ki te kaute hiko.
- TE MONI TĀWERE KI TE KAUTE HIKO: I utua te moni hua hei moni tāwēre nōtēmea nāu tēnā i tono, nōtēmea rānei koia tonu te tikanga i utua ai koe i tērā tau. Tukua mai koa ētahi wīki ruarua kia putia ai te moni hua i runga i tō kaute hiko. Hei tēnei tau koe āhei ai ki te tono haki, ki te tono moni tāwēre utu hāngai rānei ina tuku atu mātou i ngā puka whakahōu.
- TE MONI TĀWERE UTU HĀNGAI: I utua te moni hua ki te kaute pēke kua tuhua nei ki tēnei reta. Ki te mea kei te hē tēnei nama, waea 0508 ENTRUST (0508 368 7878). Mehemea koe i tono moni tāwēre utu hāngai engari i whiwhi haki kē, kō tōna tikanga, i tēnei tau kāore mātou i āhei te mahi mō he moni tāwēre utu hāngai. Hei tērā tau koe āhei ai ki te tono moni tāwēre utu hāngai ina tuku atu mātou i ngā puka whakahōu.
- Mēnā kei te pīrangā kia tere ake tō whiwhi i ō moni, tēnā whakakī mai te pepa whakakī mō te whakawhiti tika ki te kaute kei tēnei mōkihi, ka whakahoki mai ai. *Ki te kore e mārama ki a koe te puka uia koa tētahi atu kia whakamāramatia ki a koe.*
